II. REGISTRATION PROCEDURE

A. Payment of Reservation Fees

- Students planning to register for the Summer session, should pay the fee of one credit (446,000LL for undergraduate students or 604,000LL for graduate students) which will be considered towards the tuition fees of the Summer session. This amount is not refundable in case the student decides not to register for courses or drops the courses after registering for them. If the course you plan to register for is cancelled after paying the reservation fee, you need to report to the Registrar's Office to request a refund.
- Students planning to register for the Fall semester, should pay 100,000LL reservation fee which will be considered towards the tuition fees of the Fall semester. This amount is not refundable in case the student decides not to register for courses or drops the courses after registering for them.
- These payments can be made starting April 1.

B. Registration - Preparation of Schedule and Consultation with Advisors

- Prior to and during registration, April 1 16, the advisors will be available in their offices during their office hours or by appointment for consultation.

• The PORTAL of probation students will be locked for registration. Therefore, all probation students need to meet with their advisors prior to registration to unlock their files to be able to register online.

- Students who fail to register during the registration period will be fined 100,000LL late registration fee.
- Graduate Program students working on their thesis should register for 399 every semester during which thesis/project writing is in process. The correct sequence (399A, 399B, 399C, 399D...) should be followed.

III. CLEARANCE FOR GRADUATION

• Senior students expecting to graduate in July or January should fill the <u>Diploma Application</u> Form and email it to Ms. <u>Vany Parseghian</u> by April 30.

IV. PAYMENT OF FEES

- Payment of fees for the Summer session will take place from May 28 31.
- Students who fail to pay during the assigned dates will be fined late payment fee of 10,000LL per day.
