#### **REGISTRATION FOR FALL 2025 SEMESTER**

(Undergraduate and Graduate Programs)

## I. DATES:

Late Registration : August 27 – September 2

Beginning of Classes : August 27

Schedule Changes : August 27 – September 2

Processing of Statement of Fees and Installment Forms : September 8 – 11

Payment of Fees : September 13 – 17

### II. <u>LATE REGISTRATION</u>

Returning and current students who have not yet registered for the Fall semester can do so online, through the PORTAL, from *August 27 to September 2*.

### III. BEGINNING OF CLASSES:

Fall semester classes will begin on August 27.

#### IV. CHANGE OF SCHEDULE:

Change of schedule will take place from *August 27 to September 2*.

## V. PROCESS STATEMENT OF FEES AND INSTALLMENT FORMS:

Between September 8 and 11 and prior to processing your statement of fees, all Lebanese students should pass by the NSSF desk to finalize the NSSF status and then go to the Billing and the Cashier's Offices to process your statement of fees and installment forms.

Students are required to:

- 1. Complete the National Social Security Fund papers with the Personnel Officer.
- 2. Provide the Personnel Officer a copy of their personal medical insurance card (if available) before September 11, 2025.

Lebanese students are required to join the medical plan of the Lebanese National Social Security Fund (NSSF). If the student already has Lebanese NSSF, he/she needs to provide a certificate (فيمان) to the personnel officer. Parallel to the Lebanese NSSF medical plan, all students will benefit from a private medical health insurance that has coverage of up to \$7,500 in an open network (all the hospitals that are contracted by the private Insurance) for all medical emergencies. This University private insurance policy is mandatory to all students. Students who show evidence of other private medical insurance coverage that overlaps with the above-mentioned policy will be exempted from the University private medical health insurance. However, all students will be insured against personal accidents no matter what.

All above mentioned documents must be submitted prior to September 11, 2025. If students don't submit the required documents by the due date, they will be automatically insured by the University (NSSF and Private). All premiums will be applicable on the SOF.

## VI. PAYMENT OF FEES:

Payment of fees for the Fall semester will take place from *September 13 to 17*. To pay your tuition fees, **print the payment bill from your portal account** (Log in to your account, go to "Student Info" then click on <u>Payment Slips</u>.) Take the bill and follow the instructions of payment. Furthermore, an email will be sent by the Billing Office, before the payment date, explaining how to process your payments.
